## **COURSE DETAILS :**

1. **Pre-sea Training of G.P. Rating (General Purpose of Rating)** means combined training (Deck side and Engine Side both has to be trained) after completion of 6 months residential training you will get Indian CDC from Directorate General of Shipping, Govt. of

India that means you will eligible for join in ship as per your choice, you can join in ship in deck side or you can join in engine side. Once you join in ship deck side then never you will be change your stream simultaneously if you can choose to join in engine side then never you will be changed your stream.

From Deck side you can goes up to Captain (Master). According to the rules of D.G. Shipping, you have to sit for the exam from time to time and gradually pass and reach the place of Captain (Master)/Chief Engineer then you will earn 7 lakhs to 10 lakhs per month.

2. **Pre-sea Training of CCMC (Certificate Course of Marine Catering)** means students of this training are given Marine Catering and cook ideas and some ship knowledge, some deck side knowledge and some engine side knowledge, after completion of 6 months residential training you will get Indian CDC from Directorate General of Shipping, Govt. of India that means you will eligible for join in ship as General Steward.

From CCMC training you can goes up to Chief Cook. According to the rules of D.G. Shipping no examination required for the promotion of Chief Cook.

### **ELIGIBILITY CRITERIA :**

**Age Limit:** 17.6 months to 25 years as on the day course start (Course start in every year 2 time one 1<sup>st</sup> July and another 1<sup>st</sup> January)

SC/ST: age relaxation 17.6 to 30 years and OBC: age relaxation 17.6 to 28 years.

### **ACADEMIC QUALIFICATION :**

**For G.P. RATING:** Candidate should have passed in 10<sup>th</sup> or 12<sup>th</sup> standard from a Board recognized by the Government for 12<sup>th</sup> standard consideration candidates should be from science field. Candidate should have passed with overall 40% and English should have 40% in 10<sup>th</sup> or 12<sup>th</sup> along science and mathematics.

**For CCMC Course:** Candidate should have passed in 10<sup>th</sup> and 12<sup>th</sup> standard from a Board recognized by the Government and candidates should have passed with overall 40% and English should have 40% in calsss 10<sup>th</sup> or 12<sup>th</sup>.

### **ADMISSION PROCEDURE :**

The candidates who meet the eligibility for admission can apply for this course. Candidates interested to join the 6 months Pre-sea Training of G.P. Rating and Pre-sea Training course of CCMC (Certificate Course of Marine Catering) will have to apply GMS (Ganpati Marine Services) on the prescribed form which is given in this prospectus.

The candidates should have submitted complete form along with the following documents:

- \* Xerox copy of class X and XII passing certificate
- \* Xerox copy of Class X and XII Mark sheet.
- \* School leaving certificate
- \* Xerox copy of Birth certificate if necessary
- \* Xerox copy of Passport or Passport applied evidence/proof.
- \* Recent (3.5 x 3.5) colour photographs with white back ground (14 copies)

The candidates will be fully responsible for making any fake declaration, or for the submission of false certificates, will make them liable for prosecution and removal from the course. Refund will not be entertained.

After collecting and scrutinizing the application, the GMS selection Board will prepare a merit list of candidates. It will be placed on notice board of the Institute and will be informed to selected candidates.

The candidate will have to undergo written test and viva. They will be tested on the basis of their attitude and aptitude towards seafarer's profession, ability to communicate in English, general knowledge and seafaring background (not compulsory) if any.

The candidates who qualify in the final test will be subjected to a Physical Fitness and Medical examination as per MS Rules 2000 by the D.G. Shipping approved doctor.

### **MODE OF PAYMENT :**

The prospectus can be obtained by cash of amount of Rs. 500/- (Five hundred only).

## **RULES AND REGULATIONS:**

1. The standing Rules and Regulation of the Institute shall be binding on all students. This may be changed without any prior intimation to the students.
